This is to notify you that your request to update the Instructions for Use of the TaqPath COVID-19 Fast PCR Combo Kit 2.0 to; (1) incorporate protocol workflow stopping points that received FDA authorization under EUA210384/S001 and additional workflow stopping points based on in-use reagent stability data, (2) update in silico inclusivity analysis to reflect more recent SARS-CoV-2 sequences, (3) update the compatible firmware and software versions for the Applied Biosystems QuantStudio 5 Real Time PCR Instrument where listed, and (4) provide minor edits, is granted. Upon review, we concur that the data and information submitted in EUA210384/S002 supports the requested updates for use with the TaqPath COVID-19 Fast PCR Combo Kit 2.0.
